Regulations of the "EXTRA" Promotion

- 2. The promotion is conducted in:

("Stationary shop")

Hereinafter referred to as ("Organizer's Stores").

- 3. The promotion lasts from 12.02.2025, at 12:00 am CET to 26.02.2025, 2024, at 11:59 pm CET.
- 4. The Promotion consists in the fact that the Participant of the Promotion may, during its duration, take advantage of a discount lowering the applicable price of the Products available at: https://sportano.com/early-spring
- 5. Products participating in the Promotion are hereinafter referred to as "Products".
- 6. The value of the applicable discount resulting from the discount code assigned to the Product is visibly marked on the product card.
- 7. Products not marked with a discount code information are not subject to a reduction of the current price.
- 8. To participate in the promotion, you must add the Products marked with a discount code to your cart, enter the discount code "EXTRA" in the "I have a discount code" field and confirm the code. Validation of the code will reduce the prices of the applicable Products, by the percentage of the discount assigned to each Product.
