Regulations of the "HOLIDAY" Promotion

- 2. The promotion is conducted in:
- a) The Organizer's online store, available at https://sportano.com ("Online shop")
- b) The Organizer's stationary store, available at:

("Stationary shop")

Hereinafter referred to as ("Organizer's Stores").

- 3. The promotion lasts from 24.06.2025, at 12:00 am CET to 08.07.2025, 2024, at 11:59 pm CET.
- 4. The Promotion consists in the fact that the Participant of the Promotion may, during its duration, take advantage of a discount lowering the applicable price of the Products available at: https://sportano.com/holiday-sports
- 5. Products participating in the Promotion are hereinafter referred to as "Products".
- 6. The value of the applicable discount resulting from the discount code assigned to the Product is visibly marked on the product card.
- 7. Products not marked with a discount code information are not subject to a reduction of the current price.
- 8. To participate in the promotion, you must add the Products marked with a discount code to your cart, enter the discount code "HOLIDAY" in the "I have a discount code" field and confirm the code. Validation of the code will reduce the prices of the applicable Products, by the percentage of the discount assigned to each Product.
- 9. To participate in the Promotion, during its duration, you must:
- I. In the online store:
- a) add Products to the basket,
- b) before placing an order in the "basket" section enter the received discount code "HOLIDAY" entitling to obtain a discount.
- II. In the stationary store:

- 10. Providing the Participant of the Promotion with a discount code after placing an order in the Online Store does not entitle to take advantage of the Promotion. No entry of the above. discount code means that the buyer has abandoned the right to take advantage of the Promotion in relation to a given transaction. - 18. These Regulations may be changed only in the event of an important reason, which is:
- a) Change of the law regulating the conditions, rules, and organization of the Promotion.
- b) Change in the way of conducting the Promotion due to technical or technological

reasons.

- c) changing the scope or provision of services to which the provisions of the Regulations apply, by introducing new ones, modifying, or withdrawing the existing functionalities or services covered by the Regulations by the Organizer.
- 19. In the event of a change in the Regulations, the Organizer will provide the consolidated text of the Regulations by publishing it on the website https://sportano.com/ and in the stationary Store.
- 20. Amendments to the Regulations are effective from the moment they are clearly indicated and placed at the address indicated above.
