

Regulations of the "SPORT" Promotion

1. The organizer of the "SPORT" promotion ("Promotion") is SPORTANO.COM Sp. z o. o. with its registered office in Zielona Góra (65 - 427) at ul. Wrocławska 17B lok. 15 - 16, entered the Register of Entrepreneurs of the National Court Register kept by the District Court in Zielona Góra, VIII Commercial Division of the National Court Register under KRS number 0000896178, with NIP 9731077223, REGON 388722422, with a share capital of PLN 25 325 950,00 paid in full ("Organizer").
2. The promotion is conducted in:
 - a) The Organizer's online store, available at <https://sportano.com> ("Online shop")
 - b) The Organizer's stationary store, available at:
Sportano.pl, Home Park Targówek, Malborska 47, 03-286 Warsaw
("Stationary shop")Hereinafter referred to as ("Organizer's Stores").
3. The promotion lasts from 16.10.2025, at 12:00 am CET to 22.10.2025, 2024, at 11:59 pm CET.
4. The Promotion consists in the fact that the Participant of the Promotion may, during its duration, take advantage of a discount lowering the applicable price of the Products available at: <https://sportano.com/sport-deals>
5. Products participating in the Promotion are hereinafter referred to as "Products".
6. The value of the applicable discount resulting from the discount code assigned to the Product is visibly marked on the product card.
7. Products not marked with a discount code information are not subject to a reduction of the current price.
8. To participate in the promotion, you have to add Products marked with a discount code to your cart, enter the discount code 'SPORT' in the 'I have a discount code' field, and confirm the code. The minimum value of all products in the cart must be at least €79 for the discount code to apply. Confirming the code will reduce the prices of the relevant Products by the percentage discount assigned to each Product.
9. To participate in the Promotion, during its duration, you must:
 - I. In the online store:
 - a) add Products to the basket,
 - b) before placing an order - in the "basket" section - enter the received discount code "SPORT" entitling to obtain a discount.
 - II. In the stationary store:

a) The price of the products covered by the campaign will be reduced after filling the products at the cash register, before making the payment.

10. Providing the Participant of the Promotion with a discount code after placing an order in the Online Store does not entitle to take advantage of the Promotion. No entry of the above. discount code means that the buyer has abandoned the right to take advantage of the Promotion in relation to a given transaction. In such a situation, upon making the payment, he/she finally loses the right to take advantage of the Promotion in relation to the transaction made.

11. Participation in the Promotion is voluntary and free of charge. It means that the purchase of Products as part of the Promotion does not require the Promotion Participant to incur any additional costs, apart from paying the price for them and any costs selected by the Promotion Participant, e.g., delivery costs.

12. The discount cannot be exchanged for any means of payment and cannot be paid out in cash.

13. The promotion cannot be combined with other promotions, rebates, discounts, campaigns, special price, or product offers that apply in the Organizer's Stores, unless their regulations provide otherwise.

14. Complaints regarding the Promotion may be submitted by the Participants of the Promotion to the address of the Organizer's registered office or by e-mail to the address <https://sportano.com/contact>. Complaints should be submitted within 14 days of the disclosure of the reasons justifying the complaint.

15. To speed up the consideration of the Complaint, the name and surname of the Promotion Participant and contact details (e.g., e-mail address or telephone number), as well as a description of the reasons justifying the Complaint, should be provided.

16. The Organizer shall respond to the Complaint immediately, not later than within 14 days from the date of its submission.

17. Complaints are considered by the Organizer, applying the provisions here of of the Regulations.

18. These Regulations may be changed only in the event of an important reason, which is:

- a) Change of the law regulating the conditions, rules, and organization of the Promotion.
- b) Change in the way of conducting the Promotion due to technical or technological

reasons.

c) changing the scope or provision of services to which the provisions of the Regulations apply, by introducing new ones, modifying, or withdrawing the existing functionalities or services covered by the Regulations by the Organizer.

19. In the event of a change in the Regulations, the Organizer will provide the consolidated text of the Regulations by publishing it on the website <https://sportano.com/> and in the stationary Store.

20. Amendments to the Regulations are effective from the moment they are clearly indicated and placed at the address indicated above.
