Regulations of the "SWIM" Promotion

- 2. The promotion is conducted in:

Hereinafter referred to as ("Organizer's Stores").

- 3. The promotion lasts from 11.10.2024, at 12:00 am CET to 15.10.2024, 2024, at 11:59 pm CET.
- 4. The Promotion consists in the fact that the Participant of the Promotion may, during its duration, take advantage of a discount lowering the applicable price of the Products available at: https://sportano.com/swim10
- 5. Products participating in the Promotion are hereinafter referred to as "Products".
- 6. The value of the applicable discount resulting from the discount code assigned to the Product is visibly marked on the product card.
- 7. Products not marked with a discount code information are not subject to a reduction of the current price.
- 8. To participate in the promotion, you must add the Products marked with a discount code to your cart, enter the discount code "SWIM" in the "I have a discount code" field and confirm the code. Validation of the code will reduce the prices of the applicable Products, by the percentage of the discount assigned to each Product.
- 9. To participate in the Promotion, during its duration, you must:

- c) changing the scope or provision of services to which the provisions of the Regulations apply, by introducing new ones, modifying, or withdrawing the existing functionalities or services covered by the Regulations by the Organizer.
