Regulations of the "WARMUP" Promotion

- 2. The promotion is conducted in:

("Stationary shop")

Hereinafter referred to as ("Organizer's Stores").

- 3. The promotion lasts from 23.10.2025, at 12:00 am CET to 28.10.2025, 2024, at 11:59 pm CET.
- 4. The Promotion consists in the fact that the Participant of the Promotion may, during its duration, take advantage of a discount lowering the applicable price of the Products available at: https://sportano.com/black-month
- 5. Products participating in the Promotion are hereinafter referred to as "Products".
- 6. The value of the applicable discount resulting from the discount code assigned to the Product is visibly marked on the product card.
- 7. Products not marked with a discount code information are not subject to a reduction of the current price.
- 8. To participate in the promotion, you have to add Products marked with a discount code to your cart, enter the discount code 'WARMUP' in the 'I have a discount code' field, and confirm the code. The minimum value of all products in the cart must be at least €69 for the discount code to apply. - c) changing the scope or provision of services to which the provisions of the Regulations apply, by introducing new ones, modifying, or withdrawing the existing functionalities or services covered by the Regulations by the Organizer.
